



#### SN54F283 . . . J PACKAGE SN74F283 . . . D OR N PACKAGE (TOP VIEW)




# SN54F283 . . . FK PACKAGE (TOP VIEW)



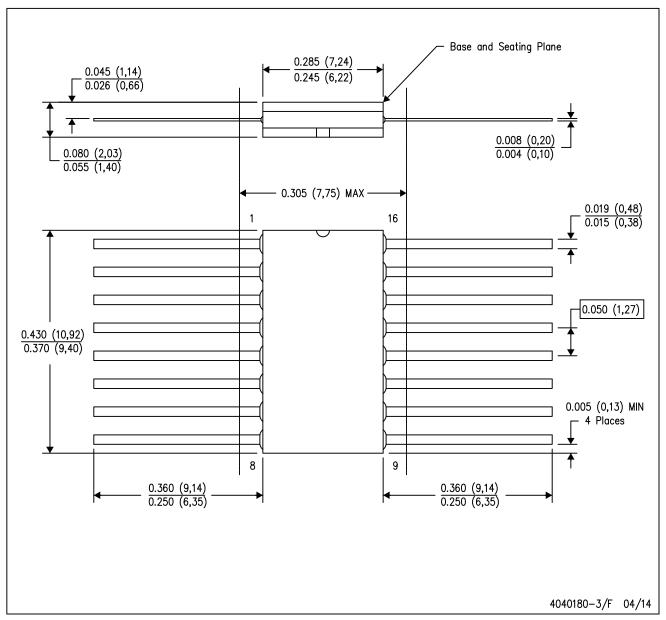
